As the only Reconstructionist camp, we realize that some families may incur significant additional costs for travel. Travel subsidies may be available upon request for costs incurred over \$200 per child (up to a total reimbursement, per child, of \$200) depending on distance from home to Camp. ** Families who choose to pay any portion of tuition by credit card (Visa, MasterCard, or American Express) will be assessed a one-time, \$100 convenience fee per family.

A confirmation letter will be sent approximately two weeks after approval of application form and receipt of deposit.

PERMISSION and AGREEMENT

- I hereby give my child(ren) permission to participate in all Camp JRF sponsored activities. I understand that this entire agreement applies to all such activities, including attending Camp JRF, the No'ar Hadash Israel Experience, and the No'ar Hadash North American Teen Kallah.
- I agree that my child's acceptance into Camp is not official until written confirmation is received from the Camp office.
- I understand that the \$500 deposit per session is non-refundable.
- I understand that if I cancel my application before February 29, 2012, all of my money, except the \$500 deposit per session, will be refunded. If I cancel between March 1, 2012 and May 31, 2012, I will still be responsible for 25% of the total Camp fees. Cancellations received after June 1, 2012 will still be responsible for 100% of Camp fees.
- I understand that I am ultimately responsible for paying the Camp tuition. I further understand that 25% of the total tuition is due before March 1, 2012 and full payment of tuition is due by June 1, 2012 and that my child's registration may be voided if approved payment arrangements have not been made with the Camp JRF office by March 1, 2012.

- I understand that Camp JRF scholarship applications must be postmarked by January 31, 2012. Scholarship applications received after that date will not be reviewed as there will not be funds available after that date.
- I understand that Camp JRF staff do not accept tips or gratuities. Our staff understands this and agrees to adhere to it in their signed contracts. Donations in honor of staff members are welcomed to the Staff Appreciation Fund.
- I agree that Camp JRF may share my family's contact information with other Camp families for communication purposes only, unless I indicate otherwise in writing.
- I agree that Camp JRF has my permission to use photographs, video or likenesses of my child for promotional purposes, unless I indicate otherwise in writing.
- I hereby agree to hold Camp JRF, the Jewish Reconstructionist Camping Corporation, and the Jewish Reconstructionist Federation harmless from any liability except for those Camp-sponsored activities.
- It is agreed that any dispute or cause of action arising between the parties, whether out of this agreement or otherwise, shall be resolved exclusively by binding arbitration in a court of competent jurisdiction located in Pike County, Pennsylvania according to the existing commercial rules of the American Arbitration Association and the substantive laws of Pennsylvania.
- I understand that part of the camping experience involves activities and group interactions that may be new to my child, and that they come with uncertainties beyond what my child may be used to dealing with at home. I am also aware that my child may participate in off-campus activities such as recreational field trips to local amusements or camping trips that involve additional risks. I am aware of these risks and I am assuming them on behalf of my child. I realize that no environment is risk-free and so I have instructed my child on the importance of abiding by Camp's rules. My child and I both agree that he or she is familiar with these rules and will obey them.
- I understand that Camp JRF does not accept responsibility for loss, theft or damage to the clothing, equipment, or personal effects of campers during the session or while in transit. Cellular phones, laptop computers, and other wireless communication devices are not permitted in Camp. Items such as these that arrive with campers will be held for safe keeping in the Camp office until the completion of the camper's session.
- As a parent, I am responsible for all transportation of my child and his/her belongings to and from Camp.
- I understand and will comply with the following: Campers are expected to arrive and depart on the opening and closing days of their sessions and to remain in Camp for the entire time. Having campers leave during a session is very disruptive to both the camper and the Camp community. Consequently, requests for exception must be submitted in writing and approved by the Camp Director prior to the start of the camper's session.
- I represent to Camp JRF that I have made and will make full disclosure of any and all medical, emotional, or social conditions and medications (including medication holidays) that may affect my child's experience at Camp.
- I understand that if my child is sent home for any reason or if I withdraw my child for any reason during the Camp season I am not entitled to a refund.
- I understand that the Camp Director reserves the right to dismiss any camper without refund who:
 - a) Willfully disregards Camp rules, or who endangers the camper's or others' safety;
 - b) Harms him/herself or other members of the community;
 - c) Bullies or physically, psychologically, and/or sexually abuses any member of the community;
 - d) Destroys Camp property or the property of another member of the Camp community;
 - e) Requires greater supervision than can reasonably be offered by the Camp;
 - f) Does not follow the Camp JRF Covenant of Behavior;
 - g) Acts in any way which the Camp Director, in his sole discretion, finds to be detrimental to the Camp community.
